Example of Rebalancing: Assuming no additional cash flows, a non-qualified Structured 60/40 Portfolio net the effect of 0.50% with an annual rebalance in September would have returned 20.29% during the 2009 calendar year. The same portfolio rebalanced in March would have returned 30.97% over the same time frame. From 9/1/2002 - 12/31/2017, the model returns are rebalanced annually on the month of the most recent model change. From 1/1/2018 - Present the model returns consist of 12 equally weighted underlying models each rebalancing annually on a designated month of the year (one equally weighted model for each month). These underlying models reflect model updates after or exactly when they occur. Please note that 2009 was marked by unusual volatility that caused a wider dispersion in returns based on time of rebalance, particularly for portfolios with both equity and fixed income. Our experience is that in most periods, the difference in return due to rebalance date is markedly lower.

Symmetry's model portfolios are diversified with approximately twelve distinct asset classes ranging from domestic large cap, small cap, bonds (2 to 5 year maturities, except in the equity portfolio where there are no bonds), real estate, and international value, etc. The comparison to the Morningstar Moderate Allocation (asset weighted), the MSCI ACWI (All Country World Index), MSCI World ex USA, MSCI Emerging Markets, Bloomberg US Government/Credit 1-5 Yr Index Bloomberg Barclays US Aggregate Bond, Bloomberg Barclays Global Aggregate, Russell 2000 and the S&P 500 are chosen to demonstrate the performance results against widely recognized indexes.
